# Cigarette Wholesaler's Return and License Renewal Will Move to the New Online Services System Effective August 12, 2019

Your Cigarette Wholesaler's Return and your cigarette wholesaler license accounts will be included in our new online services system on August 12, 2019. To help you prepare, here are some important details about filing in the new system with the California Department of Tax and Fee Administration (CDTFA).

#### File online

Go paperless! File your CDTFA-501-CW, *Cigarette Wholesaler's Return* in our online services system – CDTFA's preferred filing method.

- You will need to create a new login before you can file in the new system. See How to login below.
- We will email you a courtesy reminder prior to each filing due date to the email address on file. See How to prepare below.
- You will be able to file an amended return online for reporting periods after August 2019.

#### License renewal:

- Renew your license(s) annually by using your login for the new online services system. See How to login below.
  - We will email a renewal reminder to the email address we have on file.

#### How to login

- The current *User ID, Password,* and *Express Login* for these accounts will not be moved to the new online services system.
- You will need to sign up for a new *Username* and *Password*. We will mail a security code to the address we have on file so you can complete the login process. Watch for our letter with information about how to sign up.

#### How to prepare

Please confirm or update your email and mailing address with us at STFRegUpdates@cdtfa.ca.gov or call our Customer Service Center at 1-800-400-7115 (TTY:711), then select the Special Taxes and Fees option and follow the prompts for Cigarette and Tobacco Products Licensing or Taxes. Customer service representatives are available Monday through Friday from 8:00 a.m. to 5:00 p.m. (Pacific time), except state holidays.

#### Reporting Updates – Spring 2020!

We will incorporate the Federation of Tax Administrators' (FTA) Tobacco Uniformity, which uses common definitions, guidelines, and forms for standardized reporting of cigarettes and tobacco products. Our cigarette returns, schedules, online filing guide, and template files will be updated as we move towards uniformity standards.
