Hazardous Waste Disposal Fee 2022 Rates and Fee Ending June 30, 2022

The hazardous waste disposal fee rate increases January 1, 2022, and a new law ends the fee on June 30, 2022 ([Senate Bill 158](#); Stats. 2021, ch.73).

New fee rates effective January 1, 2022

RCRA hazardous waste treated to be a non-RCRA or nonhazardous waste	\$26.41
RCRA hazardous waste generated in a cleanup action and treated to be a non-RCRA or nonhazardous waste	\$5.72
Mining waste	\$21.05
Extremely/restricted hazardous waste	\$323.84
Incineration/dechlorination residue	\$8.10
