#### **GENERAL**

CDTFA-531- X is used to allocate the partial exemption credit for sales to or purchases for use by aircraft common carriers, as described in *Regulation 1805*. The sale must be included in line 1 of CDTFA-401-A, or the purchase must be included in line 1 for CDTFA-401-E, or line 2 for CDTFA-401-A.

#### COLUMN A COUNTY OF TRANSACTION

List the county where the transaction is reported on your local tax schedule from line 15 of CDTFA-401-A, or line 4 of CDTFA-401-E.

#### COLUMN B CITY OF TRANSACTION (IF APPLICABLE)

Enter the city where the transaction is reported on your local tax schedule from line 15 of CDTFA-401-A, or line 4 of CDTFA-401-E.

#### COLUMN C AMOUNT OF EXEMPT TRANSACTION

Enter the amount of sale or the purchase price subject to the exemption. Add all the amounts in column C.
