Register

Register online for a permit, license, or account—one click starts the process. Use the easy online system to:

- Register for a seller's permit or a special tax and fee program
- Renew an eCigarette and Tobacco, or International Fuel Tax Agreement (IFTA) license
- Add a new business location to an existing California Department of Tax and Fee Administration (CDTFA) account
- Pay Use Tax
- And more

Some permits, licenses, or accounts may require a fee or deposit. You can log in to check the status of your application(s). You may also receive email status updates.

File

File a return and make a payment in one convenient transaction, or schedule a payment for a later date.

When you log in with your username and password, you can review your returns after you file.

You can file returns online for many types of accounts:

- Alcoholic Beverage Tax
- All Cigarette Tax and Tobacco Taxes
- California Tire Fee
- Electronic Waste Recycling Fee
- IFTA
- Motor Vehicle Fuel Tax
- Prepaid Mobile Telephony Services Surcharge
- Sales and Use Tax
- Underground Maintenance Tank Storage Fee

Pay

You can make a payment for filed returns, prepayments, and other amounts due.

Paying online is available for most accounts and the CDTFA offers multiple payment options:

Electronic Funds Transfer (EFT)

Choose a method to securely transfer funds from your bank account:

- **ACH Debit Payment**
Through CDTFA's Online Services, simply provide your bank account and routing numbers.
or
Through CDTFA's third party vendor.
- **ACH Credit Payment**
Through your own bank account.

Credit Cards

Many major credit cards are accepted. A service fee will be charged by CDTFA's credit card processing vendor.

You have access to the CDTFA's services anywhere, anytime. You can apply for permits, file a return, make a payment, and much more.

When you create a username, you can:

- Access previously filed returns
- Amend a return
- Check balances
- File an appeal or claim for refund
- Receive correspondences from CDTFA
- Review your payment history
- Save payment information
- Track requests for relief and payment plans
- Update account information
- And more
