On Thursday, May 22, 2025, at 10:00 a.m., in Room NE 133, CDTFA-651 Bannon Street, Sacramento, CA, 95811, the members of the TAC will discuss the suggested immediate harvest values of timber harvested during the period July 1, 2025, through December 31, 2025, as per the attached meeting agenda.
